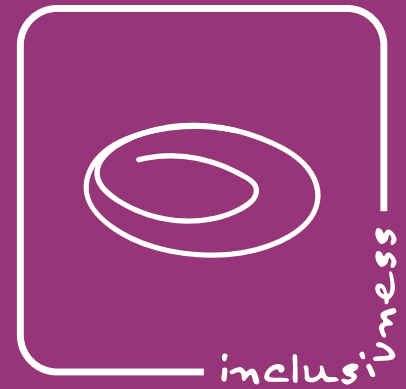

### Multilevel governance and migrant integration – How to foster effective cooperation and coordination among different levels of government?

Session co-organized with Eurac Research & Vrije Universiteit Brussel - Brussels Interdisciplinary Research centre on Migration and Minorities (BIRMM).

*Migrant integration is an increasingly important policy area for governments, but not for state governments alone. Integration is a typical case of multi-level governance. Local, regional, state, EU and international levels all have responsibilities. Moreover, immigrant integration is a cross-sectoral policy field. It is not just the task of the ministers formally responsible for immigration and immigrant integration, but also for those departments responsible for education, employment, social protection, housing and more. Whilst former and current humanitarian crises have shown the need for cooperation, we know relatively little on how coordination on immigrant integration actually works and which coordination is more efficient.*

#### *Questions to be addressed*

*How do governments cooperate across policy levels and across policy sectors? Does this cooperation run smoothly or sometimes conflictual?*

*What are the conditions for fruitful interactions?*

*Do governments cooperate regularly via institutionalized platforms, or is cooperation absent or informal?*

*And can EU actors like the European Commission and the Committee of the Regions foster effective interactions?*

*Regional and local authorities play a vital role in responding to the increasing diversity of our communities, delivering public policies and services that promote the inclusion of migrants and refugees, intercultural interaction and social cohesion.*

*The Assembly of European Regions has played a fundamental role in bringing the intercultural approach to the European regional integration, thanks to the establishment in 2019 of the [Intercultural Regions Network \(IRN\)](#), and the development and implementation of the AMIF-funded project [EU-Belong: Intercultural Integration of Migrants in Europe's Regions](#), which aims at improving the socio-economic inclusion of migrants at the regional level through the development of intercultural integration strategies. During this session, the main outcomes and policy tools developed by this European project so far will be presented.*
