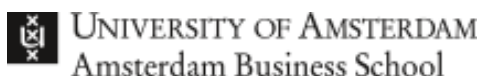

<sup>1</sup> The E-Merge initiative, implemented by IOM and funded through the Voluntary Contribution from the Italian Ministry of Foreign Affairs and International Cooperation, aims to support Italy-based enterprises, emphasizing the added value that multicultural backgrounds bring to business by contributing to both their internationalization as well as improving their developmental impact. The pilot edition was implemented between 2020 and 2022 and supported four multicultural enterprises through training, individual coaching and by assisting them in accessing credit through the partner Banca Etica. Following the pilot edition, E-Merge will continue to support and promote multicultural enterprises with a social impact based in Italy, leveraging the value of cultural diversity for the achievement of the SDGs and their internationalization.
